

- ♦ Public Acts in force (are all Public Acts that have been assented to and not subsequently repealed, irrespective of whether they have commenced)—including details of the last reprint, amendments since last print, the Minister responsible for the Act (if it has been allocated) and details of any unproclaimed and tied legislation
- ♦ Private Acts in force—including details of last reprint and any amendments since last print
- ♦ Principal Statutory Instruments—including date of gazettal, date of any reprint, date of automatic repeal under the Subordinate Legislation Act 1989 (if applicable), and any amendments since last print.
